 - Roof: High-definition composition shingles and concrete tiles are preferred. Metal is discouraged because shiny-reflective metal is unacceptable, and virtually any metal roofing, including dark colors, can be shiny-reflective at a given sun angle.

- 4. **DECKS, WALLS, FENCES, AND DOG RUNS:** Email a diagram showing the location, dimensions, materials and colors of any proposed walls, fences, and dog runs.
- 5. **PROPANE TANK:** If it is not going to be buried, identify the materials and provide the dimensions of any fencing that will be installed to conceal the tank.

- 6. **EXTERIOR LIGHTING:** Email a cut sheet and/or photograph of the Dark Sky compliant light fixtures you plan to install. These are required to be submitted prior to installation.
- 7. **TREE REMOVAL & WILDFIRE PREVENTION:** Flag trees of more than a 3-inch base diameter which are to be removed. Trees in and around the structure’s footprint and trees needed to be removed for defensible space may require approval by the Forestry Committee.
- 8. **CULVERT:** Email the Roads Committee (roads@gametrailassn.org) to determine if a culvert is needed and for specific culvert requirements.
- 9. **ESTIMATED TIME SCHEDULE:** We estimate construction will begin on the following date, and we confirm the exterior will be complete no more than one year later. Date: _____
- 10. **RENEWABLE-ENERGY DEVICES:** Approval by the ACC is required before the installation of any renewable-energy efficiency measures or renewable-energy generation devices.
- 11. **ADDRESS SIGNAGE:** Address signs are required. Reflective green and white numbered signs are available through the [Chaffee County Fire Protection District](#) (CCFPD) and are recommended by both the CCFPD and the ACC.

- f. We will ensure that our contractor and subcontractors will adhere to exterior work hours of 8 a.m. to 5 p.m. whenever on the work site.

- We affirm that upon ACC approval of the submitted building plan, it is my (our) responsibility as lot owner(s) to ensure that construction and execution of the approved plan be followed in every material respect. Should we find that any changes in the plan are needed, we will obtain prior approval from the ACC. We understand that in the event of our failure to follow the approved plan, Game Trail Association will require us to remedy the non-compliance at our expense.
- We acknowledge that we have read the [Game Trail Architectural Control Policies, Master Covenants and Covenants for our Filing, and Rules and Regulations](#) currently in effect, and agree to comply with their terms and conditions.
- To expedite ACC review, we have provided all information required. House and plat drawings/plans are being submitted digitally to scale in builder-size drawings (minimum 18" x 24" format).
- We understand that no site alteration or construction can begin until we receive written approval from the ACC.
- We acknowledge and agree that we must comply with all applicable federal, state and county laws, rules, including zoning and building codes and other regulations which apply to the ownership and use of our lot. We agree to inform the ACC upon final Certificate of Occupancy and completion of this project.
